

**Multistate Financial Institution Data Match
State Cost Reimbursement Table**

Federal law allows state legislatures the option of paying a reasonable amount to financial institutions for the cost of processing the quarterly data match. The following table indicates the reimbursement amount if allowed by state law and the address for any bills that may arise from the multistate financial institution data match (MSFIDM).
